**Selected Projects**

**BMC House, Ramat Hachayal Tel Aviv, Israel**

Architect in charge of a project which included work and office buildings situated above four underground parking levels, over an area of 72,000 sq.m in total. Executed in two stages, the project was completed in 2012.

**Assuta Private Hospital, Ramat Hachayal, Tel Aviv, Israel**

Architect in charge of a project which included planning the hospital's foundation, casing and public areas. The 10-stories building towering above four underground parking levels over an area of 90,000 sq.m, was completed in 2009.

Stage 2 of the project was a multipurpose building for clinics, medical offices and recovery rooms, in a 14-stories tower erected above the entrance level which is connected to the hospital from the west, over a total area of 16,000 sq.m. Work on this stage began in 2008 but was suspended in early 2009.

**Metropolitan Tel Aviv, Israel**

Planning a multipurpose 40-stories tower erected above four underground parking levels, including a commercial level, office levels and 24 residential levels on top. The 75,000 sq.m complex is planned at the heart of Tel Aviv's northern CBD, between Ayalon Highway to the east and Menachem Begin Road to the west.

**Tzur Yitzhak, Israel**

Architect in charge of a master plan for 500 housing units in the communal settlement of Tzur Yitzhak as well as for 230 units covering three construction compounds over a total area of 20,000 sq.m and the Tzur Yitzhak Association. The project's last phases were completed in 2011.

**Krivoy Rog Mall, Ukraine**

Planning a commercial and recreation center covering a total area of 30,000 sq.m. The project was suspended in late 2003.

**Sofia Mall, Bulgaria**

Member of the planning team, in charge of planning the office building casing over a total area of 10,000 sq.m. The project was completed in 2006.

**Block 20, Belgrade, Serbia**

Member of a planning team of a project in Belgrade, including a commercial center, hotel and offices sprawling over a total area of 155,000 sq.m (five underground parking areas and 95,000 sq.m above ground). In charge of planning the office tower covering a total area of 50,000 sq.m, as well as the hotel and commercial building's casing planning. Detailed planning up to the tender stage was completed. The project was suspended in late 2008.

**Ljubljana Mall, Slovenia**

Member of the planning team of an underground commercial center located in the Stozice Sports Park in the Slovenian capital of Ljubljana. Within the perimeter of a 185,000 sq.m compound designed for a football stadium and arena, a commercial project was introduced to cover a commercial area of 95,000 sq.m and 90,000 sq.m of parking areas in three underground

levels. The final planning for the commercial tender was submitted in February 2009 and the project was suspended in that year.
